India Virtual Internship Program

- Only Cisco Networking Academy students currently enrolled in 1st, 2nd & 3rd year technical degree {(like B.Tech, BCA, BSc (IT/CS), MCA, MSc (IT / CS)} may participate in the program.
- For students who have already completed all the recommended courses their instructors may enroll and mark them as passed in the virtual internship class they have created.
- For the students who have completed the courses through FS prime. The process is the same. The instructor may enroll and mark them as passed in the virtual internship class they have created and mark them as a pass **after** they produce their certificates of completion .

For new academies: institutions may apply to become a Cisco Networking Academy.

All on-boarding processes will need to be completed including due diligence, and onboarding fee payment, along with appointing an instructor as point of contact for these courses.

Student Process

- 1. Students will complete AICTE form
- The instructor will create the course (Nomenclature to be shared)
- The instructor will generate tokens (The # given by the partner)
- 4. The instructor will share tokens with student community
- 5. Students will enroll themselves and complete all recommended courses
- 6. Students will attend the industry session
- 7. Students will receive the certificate



Academy Process

If the institution is our existing academy, then they will nominate an instructor who will manage the course & act as a local mentor to students. The instructor will manage the process from there on.

If the institution is **NOT** a Cisco Networking Academy, then partner will decide whether they will offer the internship to them. If yes, they will be required to complete the onboarding process and nominate an instructor to manage the process.





- Instructors will create the class and generate the required number of tokens.
- The name of the class should be India_Internship_<name of the academy>_<name of the course>
- Instructor will add the instructor from partner to their academies and the classes
- 4. Instructor will distribute the required number of tokens.
- Instructor will attend the orientation session organized by the partner
- Instructor will ensure that the students register on AICTE internship portal, complete all the requirements and attend industry session
- 7. The instructor will co-ordinate with the partner to receive the certificates

AICTE process



Student Registration on AICTE Portal

Once the registration period is over, the partner will ask students to register on AICTE internships portal

Partner must collect the student enrollment details and pass onto Cisco team (Name and Academy) email id is NOT required.



Student Approval on AICTE Portal

Upon receipt of data from partner, students will be approved for internships program on AICTE portal

At end of the program, successful students will be marked as certified on AICTE portal
